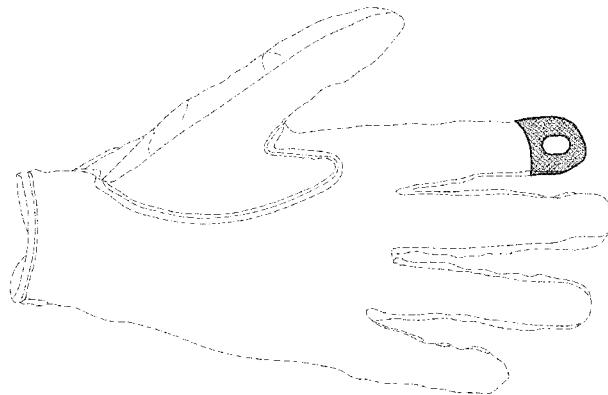
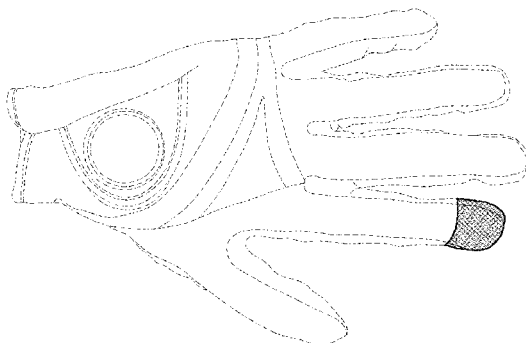
The ornamental design for a glove having contrasting region, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of a glove having contrasting region showing my new design;

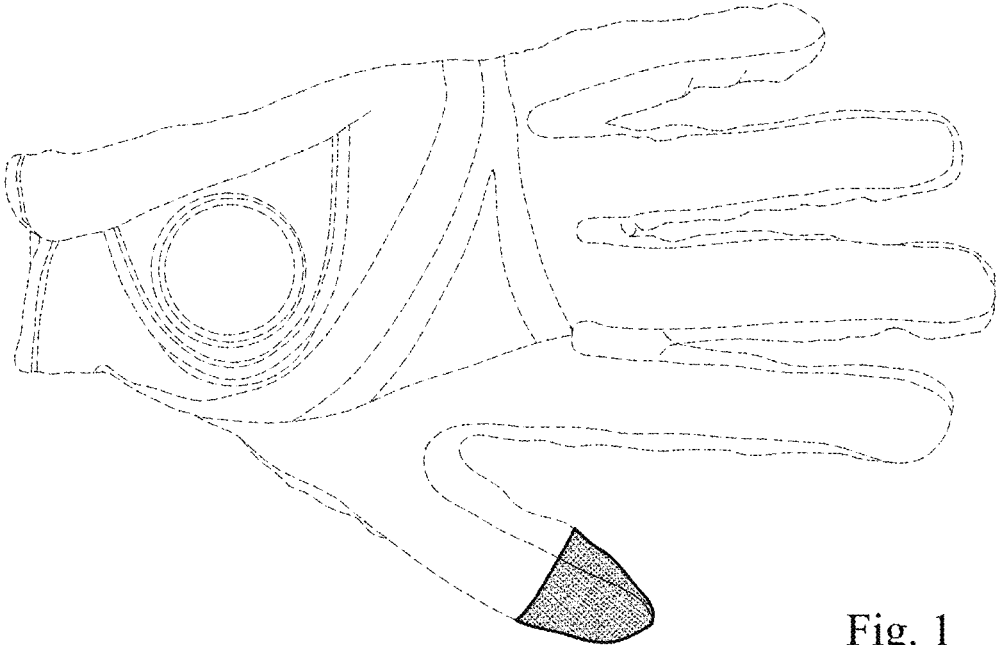

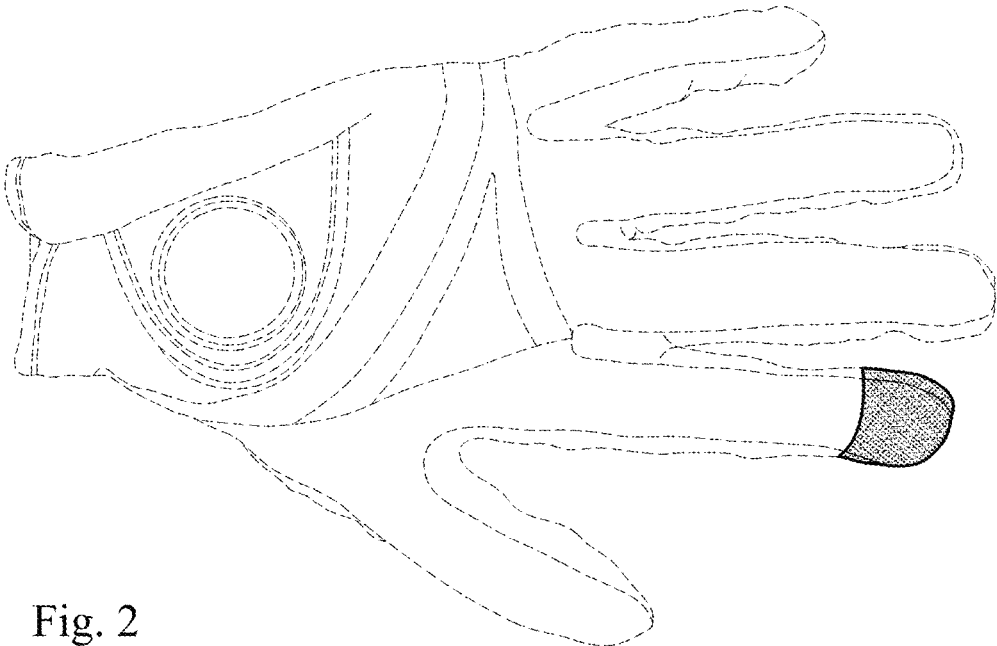

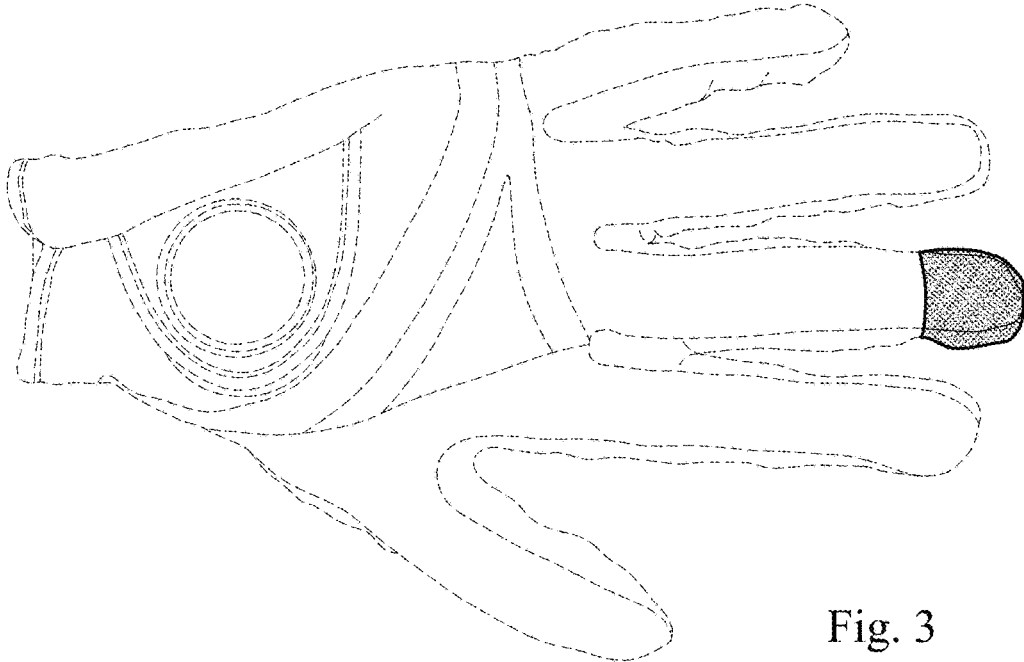

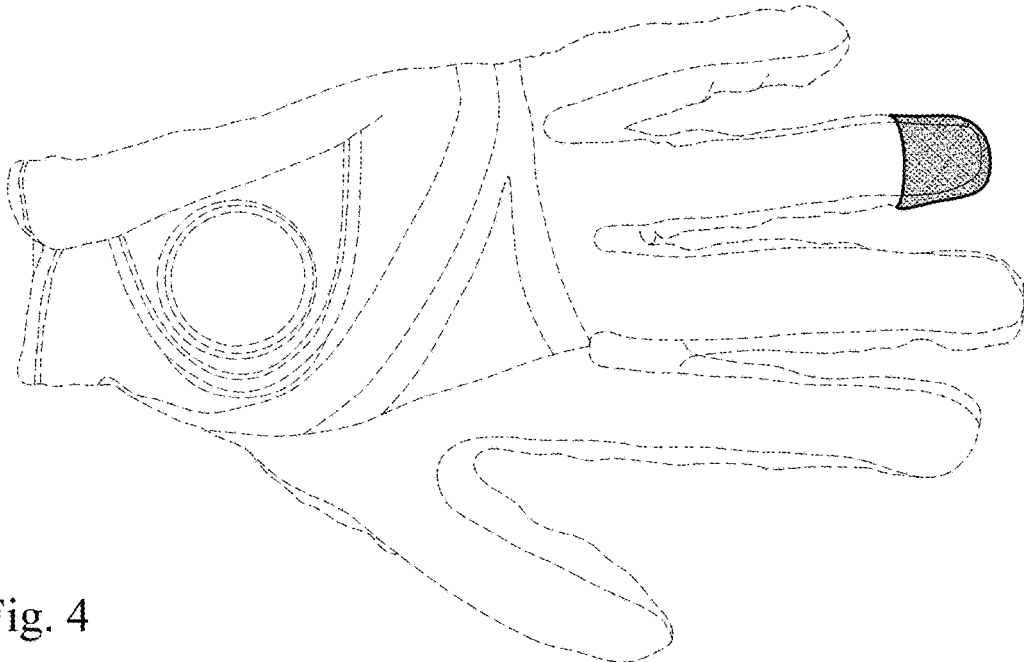

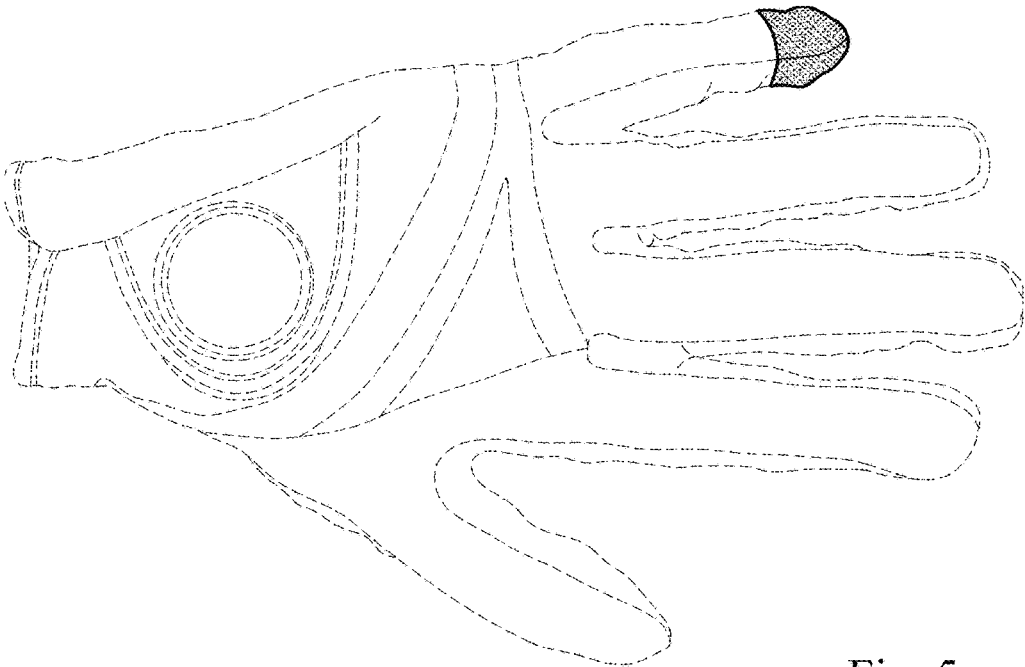

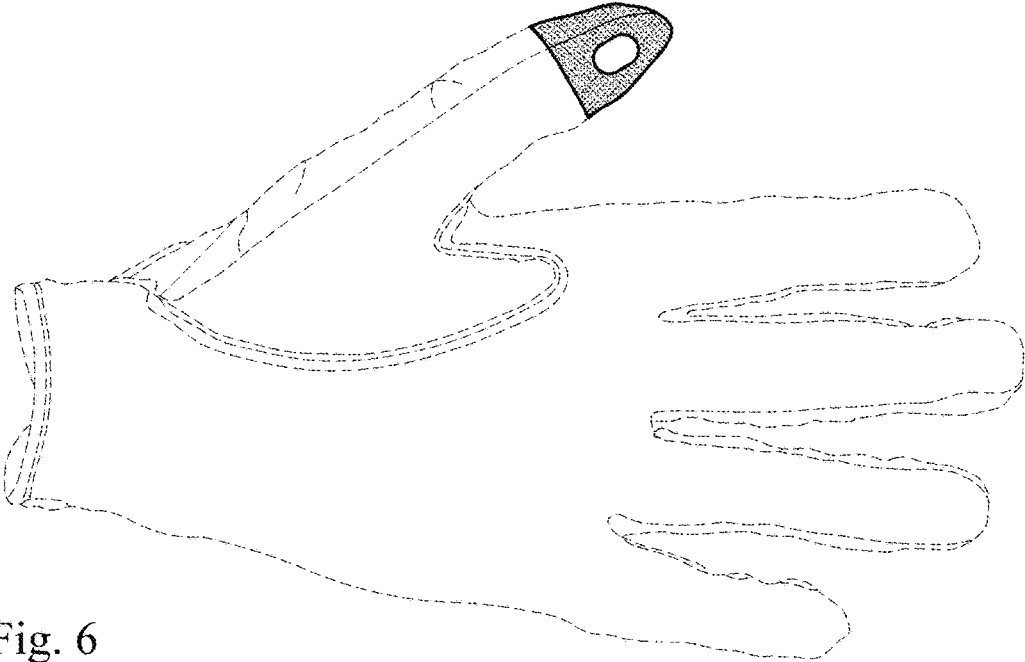

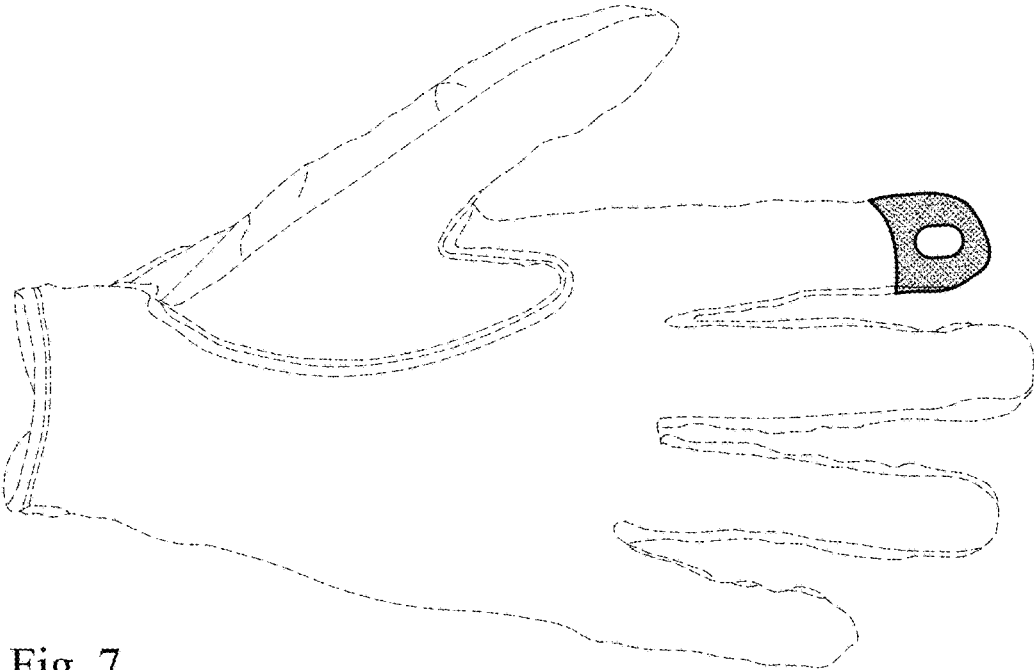

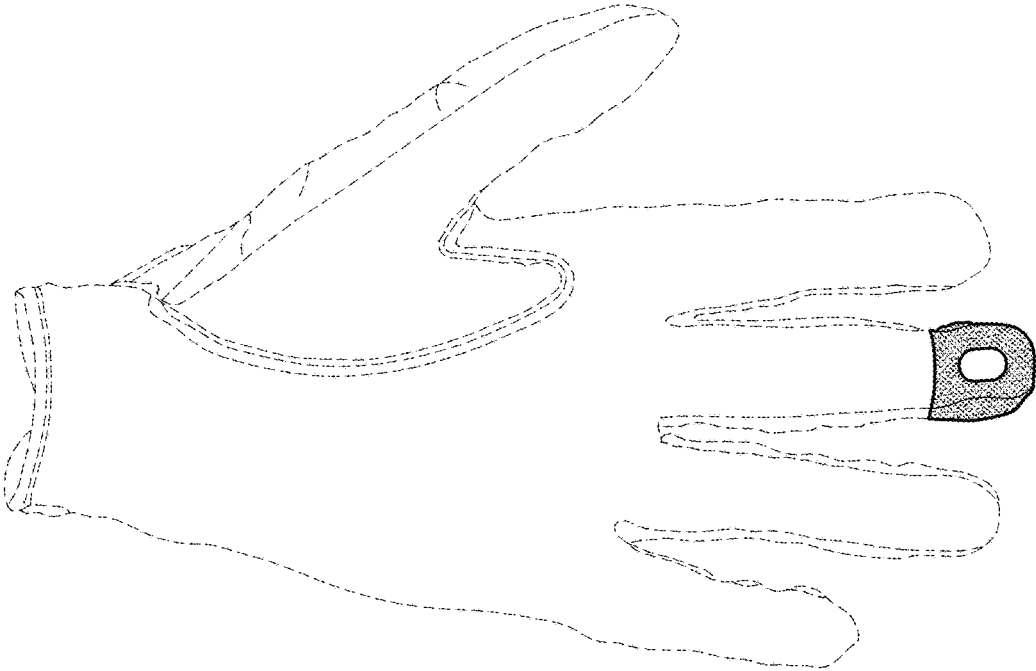

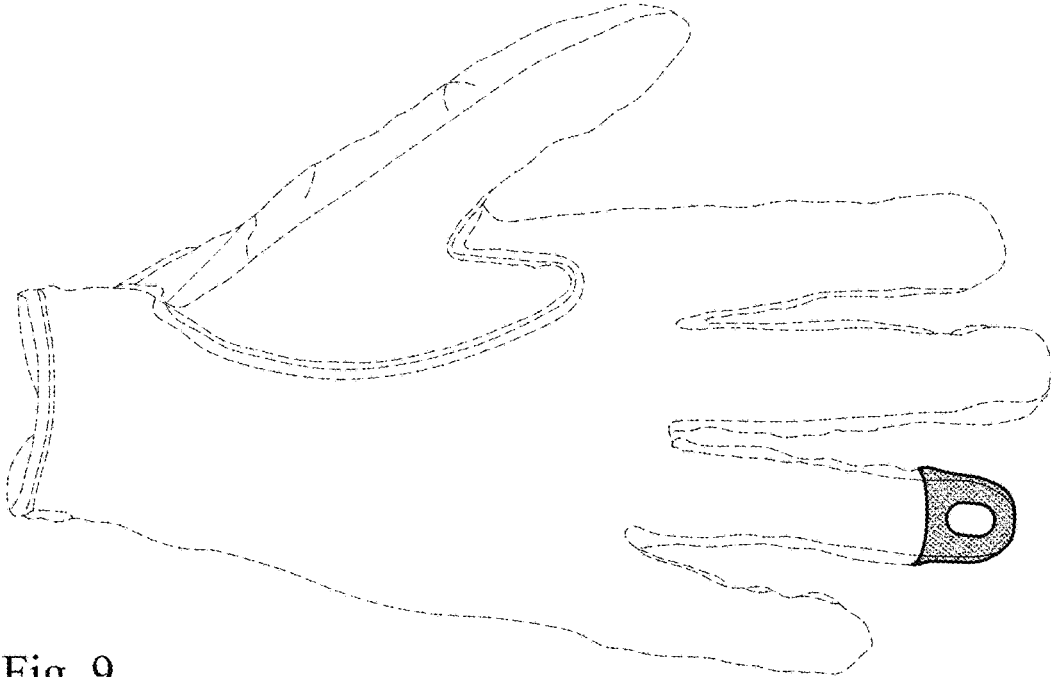

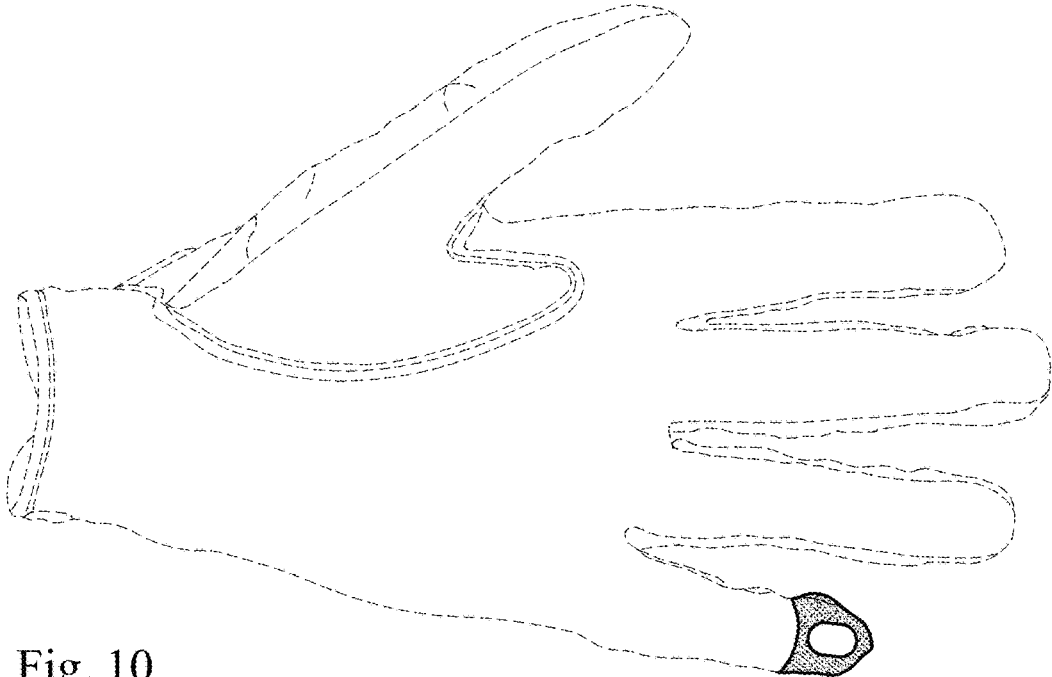
